1. PURPOSE OF AGREEMENT

The Customer hereby engages 22Autos to source, purchase, and facilitate the shipment and clearing of a vehicle from platforms such as Copart, AuctionExport, or any other auction/export platform.

2. VEHICLE REQUEST & INSPECTION

The Customer agrees to provide detailed specifications of the type of vehicle requested.

- Before any bidding or purchase, 22Autos will present vehicle details (including auction photos, description, and condition reports) for the Customer's review.
 - The Customer shall thoroughly review and approve the selected vehicle.
 - Once approval is given, the Customer **cannot hold 22Autos liable** for any condition, performance, or documentation issues related to the vehicle.

3. DEPOSIT & PAYMENT TERMS

- A **non-refundable deposit of 10% or _____** is required before 22Autos proceeds to place a bid or purchase a vehicle on behalf of the Customer.
 - This deposit is used towards the initial cost of the vehicle and auction platform charges.
 - The Customer agrees to complete payment within **48 hours** of a successful bid or purchase.

4. DEALER PROFIT / SERVICE FEE

- Upon successful bidding/purchase, the Customer shall pay 22Autos a **service fee of GHS _____ or _____%** of the total vehicle cost, excluding shipping and clearing fees.
 - This fee is **non-negotiable** and due immediately upon confirmation of purchase.

5. SHIPPING & CLEARING

- 22Autos will handle the vehicle shipment from the auction platform to Tema Port, Ghana.
 - The Customer shall pay all clearing and customs-related expenses.
 - 22Autos will provide an estimate for clearing costs, but the actual fee may vary depending on Ghana Revenue Authority assessments.

6. DISCLAIMER & LIABILITY

- 22Autos acts only as an intermediary to assist in vehicle purchase, shipping, and clearing.
 - 22Autos does not guarantee the mechanical condition or completeness of the vehicle beyond what is presented in the auction description.
 - The Customer understands and accepts that **vehicles bought through auctions may come with defects** and are usually sold “AS IS”.
 - The Customer agrees not to hold 22Autos liable for any **vehicle defects, damages, or discrepancies** once the purchase is made based on their approval.

7. TERMINATION & REFUND POLICY

- If the Customer decides to cancel the deal **before a bid is placed**, 22Autos may refund part of the deposit at its discretion after deducting administrative costs.
 - **If the vehicle is successfully bought, no refund** shall be made.
 - If 22Autos is unsuccessful in bidding, the Customer may choose to try again or request a refund minus any platform-related deductions.

8. GOVERNING LAW

This Agreement shall be governed by the laws of the Republic of Ghana. Any disputes shall be resolved amicably, and where necessary, through legal means within Ghana's jurisdiction.
